Re: Proposed Academy Conversion

We are proposing that Gayton Junior School converts to an academy and joins The Odyssey Collaborative Trust.

The education landscape is changing, as evidenced by the many schools in the city that have already converted to academy status or are currently considering this adjustment.

For that reason, during the last 12 months, Gayton's Governing Board and the school's Senior Leadership Team have been exploring the possibility of converting to academy status, looking carefully into the benefits and potential drawbacks, as well as discovering more about the range of Multi-Academy Trusts (MATs) available for us to join.

Having considered carefully how any change in status will benefit our school, we have identified one MAT, Odyssey Collaborative Trust, who we feel are the perfect match for our diverse and inclusive school. We are confident that by joining Oydssey Collaborative Trust, Gayton will continue to thrive and be able to offer the best possible education for your children. There will be huge benefits that further collaboration with Odyssey will bring to Gayton and we believe that joining them will be an exceptionally positive step for our school. Therefore we are keen to move the formal conversion process a step further.

We are committed to continual improvement and will always make decisions based on what is in the best interests of our pupils, staff and all school stakeholders; however, it is therefore very important, that we take every opportunity to consult widely with you, and are transparent in our communications.
